No late, faxed, e-mailed, telephonic or electronically submitted bids will be accepted for consideration.
3. The municipality has no obligation to appoint the lowest bidder or any bidder and reserves the right to appoint bidders individually and /or collectively to execute the contract and negotiate further conditions and requirements with the successful bidder.
4. **In terms of the National Treasury's Regulation, no bid will be accepted from the persons in the service of the state** and bidders failing to comply with the requirements of the bid document shall be submitting non-responsive bids.
