Conditions of the bids

All bids will be closed and opened in public on the date of closing at **12H00** and must be fully priced, signed and sealed in an envelope appropriately marked the name of the bid proposing-for and must be deposited into the Municipal Tender Box at the Reception of the **Fetakgomo Tubatse Municipality, 1 Kastania Street, Burgersfort or stand no 1 Ga-Nkwana Mashung**. No late, faxed, e-mailed, telephonic or electronically submitted bids will be accepted for consideration.
3. The municipality has no obligation to appoint the lowest bidder or any bidder and reserves the right to appoint bidders individually and /or collectively to execute the contract and negotiate further conditions and requirements with the successful bidder.
