#### CONDITIONS OF THE BID

Bid documents will be on sale for a non-refundable fee of R500.00 **from the 17<sup>th</sup> November 2020**, at the Cashier's Office, Fetakgomo Tubatse Municipality, Lower Ground, 1<sup>st</sup> Kastania Street, Burgersfort, from 08H30 to 15H00 during week-days or can be **downloaded for free from the e-tender portal**.

All bids will be closed and opened in public on the date of closing at **12H00** and must be fully priced, signed and sealed in an envelope appropriately marked the name of the bid proposing-for and must be deposited into the Municipal Tender Box at the Reception of the Fetakgomo Tubatse Municipality, 1<sup>st</sup> Kastania Street, **Burgersfort**. No late, faxed, e-mailed, telephonic or electronically-submitted bids will be accepted for consideration.
3. The municipality has no obligation to appoint the lowest bidder or any bidder and reserves the right to appoint bidders individually and /or collectively to execute the contract and negotiate further conditions and requirements with the successful bidder.
4. **In terms of the National Treasury's Regulation, no bid will be accepted from the persons in the service of the state** and bidders failing to comply with the requirements of the bid document shall be submitting non-responsive bids. The bid validity period from the closing date remains 90 working days.
