The bidders who score less than 70% on functionality will be disqualified.

APPOINTMENT OF SIX (6) PROFESSIONAL SERVICE PROVIDER FOR LAND SURVEYING CONSULTANTS FOR A PERIOD OF THREE (3) YEARS.

INTRODUCTION

Fetakgomo Tubatse Local Municipality invites suitable qualified professionals to submit documentation for purposes of inclusion into a panel of consultants for the municipality. The professionals required are those that specialize in the stream of work for land survey. Services will be provided on Adhoc basis for the period of three (03) years.

1. BACKGROUND

- 1.1. The municipality is faced with numerous challenges pertaining to the Land survey services.
- 1.2. These challenges ranges from encroachments in Proclaimed Townships owned by the Municipality, resolving relocation of beacons queries as per the SDBIP, provide land survey services to the community, determining boundaries of invaded land on Proclaimed Townships and farm portions owned by the Fetakgomo Tubatse Local Municipality, Subdivisions required for land disposal purposes, unregistered subdivisions, consolidations and un-surveyed Municipal properties both in urban and rural areas of Fetakgomo Tubatse Local Municipality.
- 1.3. The implications of the above mentioned, have a great impact on the correctness of ownership.
- 1.4. Moreover, the Fetakgomo Tubatse Local Municipality's Development Planning Organogram has a position for a Land Survey Technician. A Land Survey Technician has the ability to survey land but requires a professional land surveyor to certify their work.
- 1.5. As a result, it is imperative for Fetakgomo Tubatse Local Municipality to have a panel of Professional Land Surveyors that will assist the Municipality in the above mentioned duties.

The objective is to set up a panel of professional Land Surveyors in order to allow Fetakgomo Tubatse Local Municipality to draw on their skills of professional services, as and when required, to fast-track various Council projects.

1.6. SCOPE

- 1.7. The successful professional Land Surveyors will be required to provide professional services to the municipality on Adhoc basis.
- 1.8. Therefore, a more detailed indicative scope of work will be provided per each assignment, but in general, the services will encompass the following:
 - 1.8.1. To provide high level technical assessments of cadastral information.
 - 1.8.2. Resolving relocation of beacons queries.
 - 1.8.3. Provide land survey services to the community.
 - 1.8.4. Determining boundaries of invaded land on Proclaimed Townships and farm portions owned by the Fetakgomo Tubatse Local Municipality.
 - 1.8.5. Subdivisions required for land disposal purposes.
 - 1.8.6. Dealing with the unregistered subdivisions.
 - 1.8.7. Consolidations and un-surveyed Municipal properties both in urban and rural areas of Fetakgomo Tubatse Local Municipality
 - 1.8.8. Detailed cadastral and legal assessments of new land development projects.
 - 1.8.9. Preparing site, detailed, cadastral and engineering surveys.

- 1.8.10. Management and preparation of the statutory documentation for approval of diagrams and plans for council projects.
- 1.8.11. Any other related work which may be required.
- 1.8.12.Once appointed into the panel, each professional will act as the service provider when a need arises for a particular land survey assignment. However, even when appointed to be part of the panel as a professional service provider, it does not guarantee that the said service provider will be awarded any contract by the Fetakgomo Tubatse Local Municipality. Work will be allocated on Adhoc (as and when required) basis.
- 1.8.13. The service providers will be required to have the relevant working tools/equipment.

1.9. PROFESSIONAL COMPETENCY REQUIRED

1.9.1. Service Providers must comply with legislative and governmental policy requirements and be registered with the South African Geomatics Council as a Professional Land Surveyor in terms of Geomatics Professions Act, 2013 (Act No. 19 of 2013).



 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics orin purpose or utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
 - 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable.

tests and analyses	8.2	If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.

13. Incidental services	13.1	The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:

- 14. Spare parts 14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:
 - (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
 - (b) in the event of termination of production of the spare parts:
 - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and

 - 15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or placeof loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.
 - 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
 - 15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
 - 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. Payment	16.1	The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC.
	16.2	The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
	16.3	Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
	16.4	Payment will be made in Rand unless otherwise stipulated in SCC.
17. Prices	17.1	Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.
18. Contract amendments	18.1	No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.
19. Assignment	19.1	The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.
20. Subcontracts	20.1	The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.
21. Delays in the supplier's performance	21.1	Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
	21.2	If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.

 - 23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
 - 23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
 - 23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard

the intended penalty as not objected against and may impose it on the supplier.

- 23.5 Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.
- 23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

- 23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.
- 24.1 When, after the date of bid, provisional payments are required, or anti-24.
