REQUEST FOR PROPOSAL (RFP) FOR CITY DEVELOPMENT STRATEGY

INTRODUCTION AND BACKGROUND

Fetakgomo Tubatse local municipality is requesting for proposals the development of City strategy, aims to provide guidance to the developmental agenda of the municipality, to guide investment by all role players and to begin to contribute to the space economy of the municipal area. The strategy must strive to create sustainable, inclusive, productive, and well-governed municipality. The municipality is requesting for bidders to submit proposals that will present concepts towards the development of City Strategy.

1. PURPOSE OF TERMS OF REFERENCE

To appoint a service provider that will assist the municipality towards the development of City strategy, ensure that all investment made by all spheres of government and private sector begins to contribute to the restructuring of the municipality that Fetakgomo Tubatse strives to be.

2. KEY OBJECTIVES OF THE RFP

The objective is to develop the city strategy to effectively stimulate the municipal economy and give guidance to shape the municipality as visioning towards 2043. Furthermore, the strategy promotes coordination and plays a key part in facilitating sustainable development and attracting economic investment.

- To provide guidance to the developmental of the municipality.
- To identify strategic areas to attract investment and infrastructure development.
- To create sustainable, inclusive, productive, and well-governed municipality.
- To utilize the local economic comparative advantages with mining sector.
- To reposition the municipal future in line with vision 2043.

3. SCOPE OF WORK

The appointed service provider will be responsible for the following but not only limited to the below mentioned activities:

- Provide technical assistance and facilitation services in support of the strategic planning processes
- Demonstrate the similar studies/project for strategy development.
- Review and analysis of relevant documents to benchmark/ determine the planning trends in local government,
- identifying key strategic issues which the municipality needs to consider for the remainder of council term of office and beyond
- Conduct situational analysis for insight on the expectations from relevant stakeholders in respect of the strategic process and its outcomes, identifying the organizations strengths and weaknesses
- Preparation of the developmental city strategy report
- Development of strategy and strategy implementation plan

• Demonstrate the relationship with mining industries and government sectors.

PROJECT TEAM

The Project Team will consist of the appointed Service Provider and a dedicated official of the municipality to be assigned by the Municipal Manager for the duration of this project.

A project Steering Committee made up of Internal and External stakeholders shall be established to provide technical and support assistance to the process.

PROJECT EXTRA WORK

Any costs for extra work by the service provider, incurred over and above the bid price which, in the sole opinion of Fetakgomo Tubatse local municipality due to reasons attributable to the service provider during any stage of the project shall be borne by the service provider.

PROJECT REPORTING AND ACCOUNTABILITY

During the execution of the project, the service provider must submit regular progress reports as per the above project schedule and attend meetings as determined by the project team and Project Steering Committee.

All information captured and used to generate the outputs of the project remains the property of the municipality and must be handed over its totality when the project is closed. The municipality retain copyright and all associated intellectual right thereof. This document together with all agreements to be or reached during the course of the project become part of the contract. The information must be captured and provided in a digital format as agreed between the service provider and the municipality

EVALUATION PROCESS AND CRITERIA:

Evaluation of all bids received on time at closing date will be evaluated two stages:

Stage 1 of evaluation process

A) Phase 1: Administrative Compliance and

B) Phase 2: Evaluation of Functionality.

All bidders are required to comply with all the requirements of administrative evaluation for them to proceed to the next phase of functionality.

Bidders who scored more than 70% on functionality will be considered for the second stage of the process.

Stage 2 of evaluation process

C) Phase 1: Proposal and presentation

D) Phase 2: Quotations (Pricing and specific goal)

The 80/20 preference point system in terms of the Fetakgomo Tubatse local Municipality's Preferential Procurement Policy will be applicable as follows;

Price 80 and 20 Specific goals:

Specific goal

- a) B-BBEE status level of contributor 10 total points
- b) Promotion of youth 10 total points.

COMPULSORY ADMINSTRATIVE REQUIREMENT:

A bid not complying with the peremptory requirements stated above will be regarded as "non-Responsive", and as such will be disqualified. "Responsive" means any bid which, in all respects, complies with the conditions of the specifications as set out in the bid documents, including conditions as specified in the Preferential Procurement Regulations of 2022, terms of which provision is made for this policy.

Bidders will be evaluated on the following administration compliance:

- Compliant tax status (the Municipality will verify tax compliance during evaluation and adjudication stage).
- The bidder must submit company registration document (CK).
- The bidders must submit both manual and electronic tender document in the form of CD or USB for consideration.
- Latest submission of Municipal rates and taxes or municipal service invoice issued to the bidder and all directors, by any other municipality or municipal entity. The rates and taxes charges must not be in arrears for more than three months (90 days) for the company & directors.

Please note the following:

a) If staying in a non-rate-able area, please attach original letter from the Tribal Authority/ Chief or Headman

b) If the business is operated from the residence of the director, please attach the director's rates supported by an affidavit stating the address of the business premises.

- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

 - 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new productresults that is substantially different in basic characteristics or in purposeor utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
 - 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable.
