- All bids will be closed and opened in public on the date of closing at **12H00** and must be fully priced, signed and sealed in an envelope appropriately marked the name of the bid proposing-for and must be deposited into the Municipal Tender Box at the Reception of the **Fetakgomo Tubatse Municipality, 1 Kastania Street, Burgersfort or stand no 1 Ga-Nkwana Mashung**. No late, faxed, e-mailed, telephonic or electronically submitted bids will be accepted for consideration.
