Bidders must obtain a minimum score allocated for functionality to qualify for further evaluation.

Bid documents will be on sale for a non-refundable fee of **R500.00 from the dates specified above**, at the Cashier's Office, Fetakgomo Tubatse Municipality, Lower Ground, 1st Kastania Street, Burgersfort, from 08H30 to 15H00 during week-days or can be downloaded for free from the e-tender portal.

All bids will be closed and opened in public on the specified dates at **12H00** and must be fully priced, signed and sealed in an envelope appropriately marked the name of the bid proposing-for and must be deposited into the Municipal Tender Box at the Reception of the Fetakgomo Tubatse Municipality, 16st Kastania Street, **Burgersfort**. No late, faxed, e-mailed, telephonic or electronically-submitted bids will be accepted for consideration.
