All bids will be closed and opened in public on the date of closing at 12H00 and must be fully priced, signed and sealed in an envelope appropriately marked the name of the bid proposing-for and must be <u>deposited</u> into the Municipal Tender Box at the Reception of the Fetakgomo Tubatse Municipality, 1 Kastania Street, Burgersfort or stand no 1 Ga-Nkwana Mashung. No late, faxed, e-mailed, telephonic or electronically submitted bids will be accepted for consideration.
- 3. The municipality has no obligation to appoint the lowest bidder or any bidder and reserves the right to appoint bidders individually and /or collectively to execute the contract and negotiate further conditions and requirements with the successfulbidder.

In terms of the National Treasury's Regulation, no bid will be accepted from the persons in the service of the state and bidders failing to comply with the requirements of the bid document shall be submitting non-responsive bids.
