Bids shall be evaluated and adjudicated in accordance with the Fetakgomo Tubatse Municipality's Supply Chain Management Policy, Revised Preferential Procurement Regulations of 2017 and responsiveness to the bid documents, 80 points will be for price and 20 points will be for B-BBEE Level Contribution. Bidders must obtain a minimum score allocated for functionality to qualify for further evaluation.

CONDITIONS OF THE BID

1. Bid documents will be on sale for a non-refundable fee of **R300.00 from the dates specified above**, at the Cashier's Office, Fetakgomo Tubatse Municipality, Lower Ground, 1st Kastania Street, Burgersfort, from 08H30 to 15H00 during week-days.

All bids will be closed and opened in public on the specified dates at **12H00** and must be fully priced, signed and sealed in an envelope appropriately marked the name of the bid proposing-for and must be deposited into the Municipal Tender Box at the Reception of the Fetakgomo Tubatse Municipality, 1st Kastania Street, **Burgersfort**. No late, faxed, e-mailed, telephonic or electronically-submitted bids will be accepted for consideration.
