Bidders must obtain a minimum score of 60 points allocated for functionality to qualify for further evaluation.

CONDITIONS OF THE BID

1. Bid documents will be on sale for a non-refundable fee of **R300.00 after the briefing sessions**, at the Cashier's Office, Fetakgomo Tubatse Municipality, Lower Ground, 1st Kastania Street, Burgersfort, from 08H30 to 15H00 during week-days.
