# MAYOR HITTING THE GROUND RUNNING

ndeed on the 12th June 2019 I have completed my 100 days in office as the Mayor of Fetakgomo Tubatse Local Municipality and it is my pleasure to present to you our own assessment since assuming office. As we know that the local government sphere has been given responsibilities of enhancing the quality of our democracy by rooting government amongst the communities and spearheading the process of universalizing access to basic services. It is therefore important to indicate that these first days in office marked the long held quest by the African National Congress to provide basic service to all residents within the jurisdiction of Fetakgomo Tubatse.

We know that there is still much more work to be done. I must say work started in earnest on the very first day of office. My first priority was to ensure that the administration and political work continues to function optimally. To this end council has appointed Acting Municipal Manager Ms Ntsudisane Maruuen Judith (Matladi a Phogole) and Acting Chief Financial Officer Mr Sasa Mulenga(Bauba a Ngoato) respectively following the suspension of the then Municipal Manager.

The Council which sat on the 04th March 2019 gave us the mandate to lead the Municipality into a new direction. We inherited a system which was on a verge of total collapse due to reasons known to everybody. Our loss of investment made with VBS mutual bank destabilized the normal functioning of the Municipality which resulted in the declaration of Section 139(b) of the constitution and the Provincial government dispatched officials to assist us with financial recovery and good governance. We are confident that in no time, we shall have recovered from this situation.

The dire situation did not deter us from continuing with our mandate of providing services to our communities.



We have embarked on a programme of meeting various stakeholders with an objective of giving a report and to strengthen our relations. In the 100 days, we have embarked and achieved the following activities;

- Handing over of wheelchairs
- Facilitation of the fully functioning of Ga-Nchabeleng health centre
- Facilitation of the reopening of the Nthame voting station during ward 5 by-elections
- Adoption of the draft 2019/20 IDP and budget
- Hosted Take a Child to work Programme
- Meeting with Bokoni Planitum Mine Executive Management

Our immediate task is to improve the financial situation so that we can implement the projects that are the priority of our communities. At the moment the Municipality is battling to complete Operation Project and plans are underway to address the challenge. We shall continue to knock on each and every door of the decision makers to plead with them to avail more resources to be channeled towards basic services like electricity, roads, access bridges and waste management.

The road is still long and bumpy but working together we can grow Fetakgomo Tubatse Municipality.

I wish to conclude by borrowing some insightful words from the late President JKF Kennedy who had this to say:"...those to whom much is given, much is required ...when at some future date the high court of history sits in judgement on each one of us recording whether in brief span of service we fulfilled our responsibilities to the state...in whatever office we may hold will be measured by the answers to whether we were truly men/women of courage, whether were we truly men/women of judgement, whether we were men/women of integrity and whether were we truly men/women of dedication"

## **Early Life**

I was born on the 10th October 1976 at Mohlaletse (Mapasetolong Section) under Fetakgomo municipality in Sekhukhune District Municipality of Limpopo Province. I am the fifth born girl of the late Magomarele Thomas Sekwati(may her soul rest in peace) and Getrude Mankopodi Sekwati.I am baptized by the Holy Church-ZCC St Engenas in 1989. Most people in the village were attending black (African) church and it has influenced them politically, just like the founding leaders of the ANC who had mostly been influenced by churches. I grew up like any rural African girl in the village played indigenous games like moroba;taeta ;sekotšo diketo and fetch water in the river. In a nutshell I am a typical rural girl

### **Educational Profile**

Though it was hard for an African child during the apartheid era to receive education, like everyone my parents had to make sure that I received the foundation at school.

## **Primary school**

I started sub-A at Leganabatho Lower Primary School in 1985 proceeding to Mampuru Thulare Higher Primary School in 1989 and passed std. 3

# Secondary school

I attended secondary school at Fetakgomo High in 1991 were I passed std. 6 (currently grade 8) and continued up to std. 8 (Grade 10). I had to relocate to Hans-komane Secondary in 1997 because at Fetakgomo Secondary COSAS (Congress of South African Student) was not allowed to operate. At Hans-Komane Secondary school I passed my std. 10 (Grade 12).

# **Political Activist**

My political involvement started during the year of freedom in 1994. After difficult negotiation process and vigorous campaign the ANC won the first free, fair and democratic elections in 1994 I joined COSAS and became full member at Fetakgomo High School branch, this resulted in friction with the administration which led to most of comrades relocating to Hans-Komane Secondary School.

## My role in COSAS

I was the Secretary of Apel Branch of the Congress of South African Student in 1997 until 1998. As a secretary I was responsible for mobilization and organizing of students to join COSAS. I had to make sure with the collective leadership that more students become conscious about students activities and the issues which affect the learning field. We had to propagate and intensify COSAS slogan of "each one teach one".

## My role in the ANC Youth League

I joined the ANC Youth League in 1999 at Phasha-Matji Branch. I was heading the youth desk which was involved with the challenges facing the young people. My role was to mobilize and rally the youth to be aware and become politically conscious. I had to make sure that the youth join the ANC Youth League in large numbers.

In the year 2000, when Eastern Region of the ANCYL were disbanded, I was appointed as a member of the Sekhukhune Regional Task Team. My role just like RTT member was to reconstitute the Youth League Structure in the Region. In April 2001, I was elected the Regional Treasurer of the ANCYL.

# My role in the African National Congress

I was elected in the Mahlabe branch as secretary guided by the constitution of the ANC. I followed the constitution of the ANC and the branches were united.

I was nominated as an ANC Councilor in 2006 ward 4 in the then Fetakgomo Local Municipality. My role as a public representative of note was very good. I was complying with the ANC councilor guideline and the community was impressed. The ANC branch and the community nominated me for a second term in 2011.

During my period as an ANC Ward Councilor, I was appointed as a Sekhukhune Regional Task Team member in May 2013 after the disbandment of the Regional Leadership.

I was elected as an additional member of the ANC Sekhukhune Region at the Regional Conference held at Zithabiseni Resort in 2013 December. I am presently serving as the REC and RWC member of the African National Congress in the Sekhukhune Region. I am heading the Organizational Renewal Sub-Committee.

### My role in the ANCWL

I was a branch secretary of the ANCWL from 2012 till 2014. The Branch grew in membership and many women became more conscious with regard to issues and challenges affecting the women. I was organizing women during women's day celebrations and making sure that Sub-Regions, Regions, Province and National are updated about developments in our women's League Branch.

I was elected as an additional member of the Limpopo Provincial ANC Women's



League during the provincial conference in 2015. I am presently a convenor of Peter Mokaba Region of the ANCWL.

# My role as a Councilor at Fetakgomo Local Municipality

My two terms (10 years) as a councilor from 2006-2016 has been a learning curve and also a milestone. I would like to appreciate the trust the ANC and the community has shown in me. As this was an ANC deployment, my role was to execute the ANC/Community mandate.

In 2011, I was seconded to become the District Representative of which I played a pivotal role and served the ANC led municipality with dedication. This resulted in more trust by the ANC and I was seconded to the position of Chief Whip in 2014. I executed my role as per ANC mandate with success and made sure that all I was doing is in line with the ANC Manifesto. When the two Municipalities were amalgamated. I was elected as the Speaker of the Fetakgomo Tubatse after the 03rd August 2016 local government elections. I was elected the Mayor of the Municipality on the 12th March 2019 after the former Mayor resigned in December 2018.

# OPPORTUNITY TO ADD VOICE ON OUR REVISED INTEGRATED DEVELOPMENT PLAN AND BUDGET 2019/2020

t is a common cause that every five years the Municipality adopts a development plan guided by vision 2030 National Development Plan and Limpopo Development Plan respectively. The IDP is based on community needs and priorities aimed to coordinate the work of local and other sphere of government in a coherent plan to improve the quality of life for all the people living in an area. It takes into account the existing conditions and problems and resources available for development.

The IDP roadshows are considered to be one of the biggest public participation platforms where communities are afforded an opportunity to input on the development of their areas and advice council of urgent matters requiring its attention. In pursuance of our commitment to a responsive, accountable, effective and efficient Fetakgomo Tubatse Municipality and ensuring that we regularly meet with our communities to listen to their views on how best we can improve their lives, report back and explain plans, successes



and challenges, the FTLM Municipality have hosted public consultation from the 08 April 2019 to 11 April 2019

The focus of the current plan developed in 2016 was addressing failing infrastructure; financial stability; improving audit opinion and work towards special economic zone projects. From the 08 April to 11 April 2019 communities and interested groups were given opportunity to make their inputs and comments into the draft IDP and Budget. Comments and inputs shall be incorporated into the final IDP/Budget for approval on or before 31 May 2019.

Concluding one of the public participation session the Mayor Cllr Phala TN said "We have heard you and we are coming

back to you not in distance future. We are determine to work side by side with our communities and consider their inputs and comments

We are government of listening to people". I am very proud of the accomplishments that the administration has made so far but there is still more work to be done"

Transparency is one of the key factors that affects the enhancement of accountability and as a result improves the public administration performance. Therefore the public consultation serves to increase transparency and accountability in public administration. In addition, it directly impacts the quality of the policies and decisions of institutions and as a result increases the level of their implementation.

# **PUBLIC PARTICIPATION FINDS CONCRETE EXPRESSION**

s you know one of the object of local government is to encourage the involvement of communities and community organization in the matters of local government therefore the public consultation on the draft annual report was made from 25 March 2019 to 27 March 2019. Section 127(5)(a) of the Municipal Finance Management Act ( Act 56 of 2003) requires that immediately after an annual report is tabled in council. the accounting officer of the municipality must in accordance with section 21(a) of the Municipal System Act make public the annual report and invite the local community to submit representation in connection with the annual report. To this end council has adopted the annual report with reservations on the 28 March 2019 and mandated the MPAC to do thorough investigations. The investigation report is expected not in the distance future.

It is a common knowledge that our Municipality experienced many financial ups and downs over the couple of years 2016/2017 and 2017/18 financial years.

The result was a successive qualification of our financials by the Office of the Auditor General South Africa (AGSA).Put it differently the municipality received a qualified audit opinion.

The contents of the report were made public. An auditor's opinion does not judge the financial position of the reporting entity and it is an outcome of the review of a municipality's financial statements.

From the broader scheme of things, it however addresses two basic questions notably:

1.Do the statements conform GAAP which stand for Generally Accepted Accounting Principles?

2.Do they fairly represent the Municipality's financial accounts?

The literature of a qualified audit opinion is expressed when the auditor could not find sufficient evidence to support certain material balances or rather having obtained sufficient audit evidence concludes that there is a material misstatement on the financial statements

We have 105 audit findings and at the time of printing the municipality was able

to resolved 67 findings which translates into 64% of the issues raised

In response and mitigation of the findings we have instituted the Audit Action Implementation Plan with the salient purpose of restoring the sound financial management. Be it known that we will continue to raise awareness regarding the need for a collective consciousness of good governance, an understanding of the importance of clean administration in ensuring response to service delivery and also understanding of importance of ethical leadership

The Acting Municipal Manager has in addition developed weekly schedule of audit steering committee to track implementation of audit finding. With the pace at which we are moving definitely the municipality would improve.

Some of the issues will be adjusted during the preparation of interim Annual Financial Statements (AFS). We have also suggested that Interim Financial statements must be prepared by internal staff in order to rectify any errors arising.



cted within the bounds of the Law the Honourable Mayor Phala TN has convened the two days strategy and planning session as part of the IDP Review Process on the 19-20 March 2019 at Lapeng Lodge in order to review the organisational vision, mission, short and long term objectives and strategic direction. For the first time the planning session was attended by all level 1 managers; directors and members of the executive committee.

The Mayor opened the meeting and addressed the participants on numbers of issues. Quoted verbatim she said"

We are gathered here today in this fashion with a single intention that of unblocking the bottlenecks and to unravel the complexities faced by our institution in its quest to deliver the much needed services to our people. We cannot be counted in the numbers of dysfunctional municipalities and yet we have councillors and officials who are on daily basis hard at work".

The Integrated Development Plan (IDP) process is a legislative requirement through which municipalities prepare strategic development plans for a five-year period. The objectives of the strategic planning session are to provide a

broad reflection of the municipality's conceptualization of the back to basics as an integral instrument of a developmental local government, to appraise the department of Cooperative Governance; Human Settlement and Traditional Affairs (aptly referred to as ;Coghsta) on the organizational performance of the municipality in discharging its local governance mandate.

It is further aimed at highlighting strategic and prudent areas of required support to enhance the organizational performance records and finally to allow a platform of a theatre of engagements to solicit collective understanding and approach in implementing and accounting on the back to basics in order to strengthen social contract between the Fetakgomo Tubatse Local Municipality and its local communities.

The following municipal key performance areas were discussed extensively in the session:

Municipal Transformation and Organisational Development

Spatial Rational

Basic Service Delivery and Infrastructure Development

Good Governance and Public Participation

Local Economic Development

Financial Viability and Management

The discussions resulted in the formulation of a report that will be adopted by council and drive the organization's strategic plan. It will therefore require change, hard work, leadership and unity and time management especially to increase effectiveness; efficiency and productivity.

# MAYOR PERFORMS DUE DILLIGENCE ON LEBOENG ACCESS ROAD D4154



R12million road construction project was visited by the Mayor of Fetakgomo Tubatse Cllr Phala Tlakale Naume and accompanied by Executive Committee members and Director Technical Services Mr LT Gabaganenwe on Monday 15 April 2019 in/at ward 01 Leboeng village.

The D4154 road construction started on the 12 March 2018 by the appointed contractor Mercy Civils and Khabani Logistics Joint Venture at the tune of R12 289 473.56.

The visit was prompted by the slow progress and the service provider was requested to develop accelerated plan aimed to ensure that the project is completed. The road work will cover 3.3 kilometers and it is estimated to be finished within a year. The project includes but not limited to segmented pavement, Culvert Bridge, Kerbs and Edge beams.

Speaking during the visit the Mayor said the construction of the road would have positive impact on the municipality as it would reduce travel time, improve the transportation of people; enhance road safety and also reduce the dust pollution along the route.

Furthermore monitoring the project while still under construction helps to minimize sub-standard or poor workmanship which compromise quality of service provided by the municipality. To improve directors

and heads of portfolio committees were directed to visit projects monthly to take stock. Assess progress and monitor to avoid surprises.

The road infrastructure investment is in support of the municipality's development initiatives that seek to create jobs and reduce poverty.

The municipal budget continues to be under severe pressure as a result of reserves invested in the VBS bank and therefore any cent spend should be appropriately accounted for concluded the Mayor.

hrough monthly reports of Community Development Workers as they conduct liaison work activities they have compiled audit of all disabled people in dire need of wheelchair. The Municipality together with Twickenham mine management officially launched the municipal Easter Holidays' Arrive Alive Campaign at Twickenham Junction along the R37 road. Most of Christians from Mpumalanga will cross over this Municipality. This is a time for family members to reunite and reconnect with each other, time for many community and family activities

Arrive Alive is a national campaign run by all police and traffic officials. Roadblocks will be set up across the country, where officials will check on roadworthy vehicles, drunken driving and reckless driving. One of the main focuses of the campaign would be on increasing enforcement regarding overloading of passengers in private cars, bakkies and taxis. All public transport operators must ensure that their vehicles are roadworthy and that they do not put other people's innocent lives at risk.

In addition, patrols, roadside checkpoints, speed monitoring and road safety awareness campaigns will also take place. "Law enforcement officers will be on the roads to check about a million vehicles and motorists until 05 May 2019," Mayor Phala said.

There would be no tolerance for drinking and driving, she warned. Mayor Phala urged everyone to take responsibility. "We all need to be responsible on the roads this festive season," she said. "We are losing too many lives over road accidents. The campaign calls on the reduction in road deaths as urgent and non-negotiable. "To drivers, cyclist, motor bikers, pedestrians, passengers we are saying let us work together to make sure we have safer roads for all who use them. Motorist were advised to obey traffic rules, exercises maximum patience on the road and do not to drink and drive' concluded the mayor

It had been found that human error caused 90 percent of all the accidents in South Africa. We cannot continue treating road deaths as normal when we are

facing death by design, death by human error, death through carelessness, death through drunkenness, all of which can be stopped

South Africa is a signatory to the United Nations Decade of Action for Road Safety 2011-2020 which committed itself at an international level of reducing fatalities by 50% by the year 2020.

Just to update the public the road death statistics for 2019 Easter weekend showed decline of 41% compared to 2018. This means police and traffic officers had managed to reduce crashes and fatalities on the roads. This is commendable although we aimed zero death.

# AT LONG LAST KOPPIE VILLAGE GOT ELECTRIFIED

here was joy and happiness for residence of Rietfontein outside Burgersfort along the road that connects Steelpoort and Lydenburg when finally they got electricity in their homes since the inception of democracy. The happiness comes after the Mayor Cllr Phala TN accompanied by her Executive Committee members and Eskom personnel switch on electricity for the first time to the people of Rietfontein(Koppie) on the 23rd of April 2019. Koppie is one of the villages under Operation Mabone project. The electrification projects commences on the 30th October 2018 and eskom requested the municipality to pay the budget quote before any work resumes.

However due to budgetary constraints the municipality negotiated to pay for Koppie village, It was agreed that other villages will be paid as soon as the municipality gets sufficient funds for the project.

In her remarks when addressing community members the Mayor indicated that it is the responsibility of the municipality and Eskom to provide residence with electricity as it is their mandate. Even though Eskom is still working onside but all the remaining households will be electrified: said the Mayor.

fter looming shout down by communities around Fetakgomo Tubatse regarding the conversion of Nchabeleng Community Health Centre into a fully fledge hospital, Limpopo MEC for health Dr Phophi Ramathuba visited the facility on the 30th April 2019 to engaged relevant stakeholders to seek amicable solution. The stakeholder meeting was attended by Fetakgomo Crisis Committee; Apel SAPS; Fetakgomo Taxi Association; Traditional leaders from Tau Nchabeleng; Tau Mankotsane; Masha Makopole:Marota Mohlaletse, members of hospital board; officials from the department of health led by Ms Linah Maepa and the Mayor of Fetakgomo Tubatse Cllr Phala NT.

Nchabeleng health Centre started operating in 2000 without permanent doctor and not offering services like Dental services, Operations and Radiography services. During the engagements the MEC undertook commitment on the following areas:

In the short time the MEC directed that a dental chair be sought at Meckenburg hospital and be relocated within the next seven working days. Operation services theatre was assessed and the findings suggested that new equipments needs to

be purchased. With regard to Radiography services; Mr Tjebane Kgaditsi Bauba was requested from St Ritas hospital to assist at Nchabeleng health centre .Now the department has appointed Dr Ramaila MI and Dr Ddlovu NM to assist on the day to day work. The MEC has also committed to recruit two additional professional Doctors to come and work at Nchabeleng CHC on or before the end of 2019.

In the long time the MEC has resuscitated the interim board to work on drafting Memorandum of Understanding(MOU) for all outstanding functions including but not limited to status of the facility, budget and gazetting the hospital for approval from National Minister of Health and develop acceleration plan for implementation.

Worth reporting since the visit by the then MEC Kgetjepe Ishmael on the 19 May 2014 accompanied by Head

of Department Dr Kgaphola Peter the following has improved.

- Appointment of two data captures;
   04 PHC trained;06 enrolled Nursing assistance and 09 midwife
- Dental section is operating
- · Two Dieticians are also onsite daily
- The facility was given water purification machine which supply drinking water and autoclave of medical equipment's

The interim board is comprises of the following members:
