I greet you all in the name of working towards a clean audit.

Madam Speaker and members of Council, our term of office was with effect from the 03 August 2016 after the Local Government Elections and we resumed office on the 17th August 2016, after the de-established two local municipalities i.e. Fetakgomo and Greater Tubatse Municipalities and the new established

Fetakgomo-Greater Tubatse Municipality which was with effective under Section 12 Notice.

Madam Speaker like any other Council established in our Country, we went through inductions as to how members of Council should perform their functions when providing and delivering services to our communities.

The Municipal Public Accounts Committee (MPAC) attended a session conducted by COGHSTA to empower members on roles and responsibilities and to analyze reports.

The Council on its sitting held on the 27 October 2016, 07 December 2016 and 30 January 2017, referred some reports for MPAC scrutiny in this regard our focus was on the 2015/2016 Draft Annual Report Resolution No OC56A/2017. The committee will submit other outstanding in the next Council.

We manage to arrange several capacity sessions which were meant to further enrich and capacitate our members to deal with the task given by Council.

Madam Speaker and Council we have analyzed the 2015/2016 Draft Annual Performance Reports for the former Fetakgomo and Greater Tubatse Municipalities.

We have noted the following contributions made during the year under review:

- (a) that there should be an ongoing engagements with Sector Departments in terms of services provision by them e.g. schools, clinics etc.;
- (b) that service delivery on electricity has improved almost 5889 houses have been electrified in year under review;
- (c) That 5788 indigent households benefited from Free Basic Electricity (FBE);
- (d) that construction of water storm drainages, road maintenance, fencing of rural cemeteries, waste removal etc., has contributed positively to our communities;
- (e) the comparison Municipal Performance since 2013/2014 to date;
- (f) that there should continuous Mining forums especially on the commitment as provided by their social labour plans through the office of the Mayor;
- (g) that there should be constant regular monitoring on implementation of our capital and other projects within the jurisdiction of our municipality;
- (h) that departments must make sure that targets set in the SBDIP are met as planned;

With reference to Resolution No OC56A/2017 the Municipality has complied, we therefore Madam Speaker confirm before Council that MPAC Committee was part of such public meetings:

During our assessment of the 2015/2016 Draft Annual Performance Report for we have identified the following areas that needs attention:

 a. that Key Performance Indicators were not met as expected in the various compared years, 2014/2015 and 2015/2016;

- that departments should make sure that departmental targets are met as projected in a particular financial year;
- c. that the municipal assets must be verified on regular basis i.e. at least once per quarter;
- d. that the municipality should improve on the compilation of the Annual Financial Statements;
- e. that the Municipality had disclaimer Audit Opinions from AGSA in the previous financial years;
- f. we also managed to issue out questions to the Mayor / Accounting Officer seeking clarity from the 2015/2016 Draft Annual Performance Report;
- g. the questions were responded and submitted to MPAC Committee, and the committee resolved and agreed with responses hence the tabling of this report before Council.

Madam Speaker the Municipal Public Accounts Committee issued a program to conduct Public Participation on the Draft Annual Report in various venues within the Municipality which involves all stakeholders.

In the light of the above the Public Participation was advertised on the local newspaper Steelburger and other local radio stations;

- e. we hope that together as one we will drive to an unqualified opinion in the 2016/2017 Financial Year.







"Till Tubatse" I answered in hope that she will give up, I don't like running with people that don't have running experience because they also stop after every 100m. "I think I am going to join you." I ignored her because really, this 50 something year old woman will waste my time. As I was stretching, she shows up, fully dressed and ready to run. I decided to amuse her and give her a 15minutes head start just so she doesn't slow me down. When I eventually joined the race, I didn't see her till 3.5km later, AT TUBATSE. And she managed to return home running again. We all had our jaws on the floor. This old woman managed to do better than most of the people I have ran with. I was thoroughly humbled; I learned two lessons that day. Firstly, it is never too late to start. And secondly, never underestimate the power of haind.

Let me clarify that my mum is healthy. She did not get a scare where the doctor told her she needs to eat or exercise; she just started running because it is good health practice. Apparently, she has been running 250m to church, to attend Morning Prayer, and then run another 250m back home for a while. Then she pushed herself extra harder. You should have seen her when she reached Tubatse; it was like my niece finding wine gums in my handbag-a mixture of endorphins and excitement. It got me wondering, how many of us don't want to start from the beginning because we think it is too late? We think it is too late to pursue our dreams, or to start a degree from start, or work on that relationship that seemed to have died, or even work on ourselves. We are ok with being in the financial mess we are in and being stuck with those habits. We are simply ok with being the mediocre version of ourselves because we believe it is too late.

I have heard the saying 'broken glasses cannot be fixed'. I disagree with that, some broken glasses can be fixed; it depends on your will power-what are you feeding your mind? As much it might seem impossible to "so late in life", you can still do it. I said to my sister you know why mama was able to run to Tubatse? She kept on telling herself that 'I can reach Tubatse, it is not' "at far, it is within reach. I can do it... I can do it!" Ti how she got there. Not because she is a fit person but because she had programmed her mind to think and achieve what she wanted to achieve." And it is really the same with life, the people that are not scared to start from the beginning, the people that manage to actually achieve, are the ones that told themselves that

"I CAN DO IT-NO MATTER HOW TOUGH IT IS...NO MATTER HOW BROKEN THE SITUATION IS... NO MATTER HOW SILLY THIS LOOKS OR WHAT PEOPLE WILL SAY ABOUT MY TIMING OR MY AGE... I WILL START AND I WILL SUCCEED.

Imagine the fulfilment these people get? Because they went against all odds and pursued what seemed impossible. My aunt Lethabo started her medicine degree in her early 30s, its seven years later and she will be graduating in December. She says she was the oldest in her group but she managed, she put her mind to it. She sacrificed time with her family, a stable salary she was getting to get her medicine degree in her late 30s. So young person, are you happy with your where you are? If not, what is the reason? Do you think your best life is achievable? If so, what is stopping you from achieving your best life? Is it the fear of failure? Or the fear of what everyone will say? Is it pride? Whatever the case, it is never too late to start. Start at the beginning, with the right mind frame; be determined to win and it will be so!!




Brenden Ledwaba with Black Molion on his birthday
