No late, faxed, e-mailed, telephonic or electronically submitted bids will be accepted for consideration.
- 3. The municipality has no obligation to appoint the lowest bidder or any bidder and reserves the right to appoint bidders individually and /or collectively to execute the contract and negotiate further conditions and requirements with the successful bidder.
