NOTICE OF A ISSUANCE OF WASTE MANAGEMENT LICENCE FOR THE DECOMMISSIONING (CLOSURE) OF THE BURGERSFORT LANDFILL SITE, FETAKGOMO TUBATSE LOCAL MUNICIPALITY, SEKHUKHUNE DISTRICT, LIMPOPO PROVINCE

Notice is hereby given in terms of Chapter 5 of the National Environmental Management Act (NEMA), 1998 (Act No. 107 of 1998) and Waste Management Activities listed in terms of the National Environmental Management: Waste Act, 2008 (NEM:WA) (Act No. 59 of 2008), as amended, of the issuance of a Waste Management Licence for the closure of the Burgersfort Landfill Site, Fetakgomo Tubatse Local Municipality, Limpopo Province.

SLM Engineers, on behalf of Fetakgomo Tubatse, appointed Mulaifa Development Projects as independent Environmental Consultants, to undertake the Basic Assessment Process and the Closure Licence Application for the landfill site. The Waste Management Licence for the Burgersfort landfill was issued by the Limpopo Department of Economic Development, Environmental and Tourism (LEDET).

According to the National Environmental Management Waste Act, 2008 (Act No. 59 of 2008), as amended, the closure licence the Burgersfort landfill site required that a Basic Assessment application be undertaken as per the NEM: WA 2008 Listed activities (Government Notice 921 of November 2013).

As a registered Interested and Affected party in the project, you are hereby notified of the issuance of the Waste Management Licence dated 26 June 2019, which was received by Mulaifa Development Projects on the 28th of June 2019. A copy of the Waste Management Licence, with reasons and conditions for the issuance of the Licence, can be made available to you on request.

An appeal against the decision must be lodged in writing to the competent authority who issued the Licence in terms of Chapter 2 of the EIA Regulations 2015, published
