Bids shall be evaluated and adjudicated in accordance with the Greater Tubatse Municipality's Supply Chain Management Policy as amended, Preferential Procurement Policy Framework Act 5/2000, 2011 Procurement Regulations and responsiveness to the bid documents, functionality and on a 90/10 point system, of which 90 points will be for price, 10 points will be for B-BBEE Level Contribution.

## **CONDITIONS OF THE BID**

- Bid documents will be on sale for a non-refundable fee of R200.00 from the day of the briefing (after the briefing session), at the Cashier's Office, Greater Tubatse Municipality, Lower Ground, 1<sup>st</sup> Kastania Street, Burgersfort, during week-days.
- 2. All bids will be closed and opened in public on the 25 February 2016 at 12H00 and must be fully priced, signed and sealed in an envelope appropriately marked the name of the bid proposing-for and must be <u>deposited</u> into the Municipal Tender Box which is accessible 24 hours and 07 days a week at the Reception of the Greater Tubatse Municipality, 1<sup>st</sup> Kastania Street, Burgersfort. No late, faxed, e-mailed, telephonic or electronically-submitted bids will be accepted for consideration.

- 3. The municipality has no obligation to appoint any bidder and reserves the right to appoint bidders individually and /or collectively to execute the contract and negotiate further conditions and requirements with the successful bidder.
